Import and circulation of goods specified in Clauses 1-11 of the present Part is carried out upon availability of a document confirming their safety in accordance with Clauses 17 and 30 of the Regulations for procedure of state sanitary-and-

epidemiologic supervision (control) over individuals and transport vehicles crossing the Customs Union customs border, controlled goods moved across the Customs Union customs border and on the Customs Union customs territory.

Raw material, active ingredients, intended by the manufacturer (producer) only for the production of perfumery and cosmetic products, household chemical products, plant-protecting, fumigation, pest control and extermination products, as well as pharmaceutical products, are not subject to state registration.
